According to the order of the honorable Chief Judge Edward R.Korman I direct certain offers concerning distribution of unclaimed residual funds of the Swiss banks assigned for payments to victims of the Holocaust.

The given offers are about Ukraine. During the Second world war Ukraine has lost 1.7 million Jewish population in the Holocaust. At the present time there are 4 000 victims of the Holocaust living in the country. We think, that it is necessary to direct the most part of the residual founds of the Swiss banks to survivors in the Holocaust, taking into account, that their number is quickly and inexorably reducing.

**We propose:**

1. In the name of justice to make monthly payments to Holocaust victims who are living in Ukraine in the same amount, as to the survived victims in the Western countries. The number of the recipients is approximately 3000. Now the amount of monthly payment is \$160 to one person, on the West one person gets \$320 .  
Annual compensation of underpays it is necessary - **\$5.76 million.**
2. To provide monthly compensatory payments to people who were in Nazi concentration camps less than 6 months, and in ghetto or on an occupied territory less than 18 months (by criteria of German government these individuals don't receive any payments). Quantity - 1 000 persons. The proposed amount for the monthly payments is \$320 to a person (as in item 1).

Annual operational (maintenance) expenses - **\$ 3.84 million** .

3. The prisoners of a ghetto and concentration camps have received the help from the German government and compensatory payments from German federal fund «Remembrance, responsibility and future » in amount from 8 000 till 12 000 Euro. People, who were saved on the occupied territories, especially children who lost their parents and by miracle were saved from shutting, are offended because they didn't get anything except monthly pension. Quantity – 180 persons. It is offered to make once-only payment to this individuals in amount of \$5 000.

The total sum for payments - **\$900 000**.

4. To provide only-once payments to the Righteous of Ukraine (those who saved Jews during occupation) who have not yet passed a procedure of the approval in the Israeli Institute Yad Va Shem. Quantity - 120 people, the suggested size of payments - \$5000.

The total sum necessary for payments- **\$600 000**.

5. To provide financing of building and functioning of 5 houses for elderly people - Holocaust survivors- in the cities of Kiev, Odessa, Vinnitsa, Kharkov, Chernovtsy all together for 100 person.

Cost of construction project – **\$3.1 million**

Cost of maintenance - **\$375 000 per year**.

6. There is a suggestion to create a fund for financing of expensive medical treatment and execution of complicated expensive surgeries (heart surgeries, replacement of joints) at the Ukrainian Centre - The American Jewish Distribution Committee Inc.

It will require about **\$600 000 per year**.

7. To give a part of financial means directly to the organisations of former prisoners of Nazi concentration camps and ghetto, for social, household, medical-rehabilitation and national-cultural purposes, and also for organisational activity of the or-

The sum of financing - **\$250 000 per year.**

8. Besides the humanitarian purposes, to provide allocation of financial means for:

- realisation of projects that serve to mutual understanding between nations and that are a reminder and warning about the danger of totalitarian systems and tyranny, xenophobia and anti-Semitism;
- research programs about the Holocaust;
- preservation of memory about Catastrophe , etc.

In particular for this purpose it is necessary to build:

A Memorial Complex Babiy Yar in Kiev, it will include a museum and a scientific research institute of the Holocaust.

Cost of construction project - **\$10.3 million**

Annual operational (maintenance) expenses – **\$95 000 per year.**

A memorial of Jews- victims of Nazism in Odessa.

Cost of construction project - **\$1.5 million.**

Annual operational (maintenance) expenses - **\$11000 per year.**

Monuments and memorial boards in the places of mass executions of Jews.

There are more than 1000 places like this, and only 300 of them marked by monuments.

The amount of expenses for erection of the new monuments - **\$210 000.**

Comments and substantiation of the resulted expenses will be sent till March, 12, 2004.

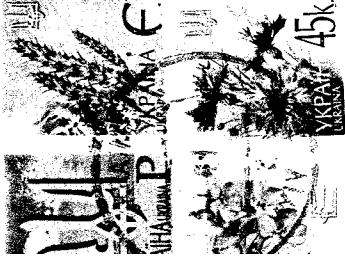
