
Dear Master Judah Grebetz, dear Chief Judge Edward Korman,

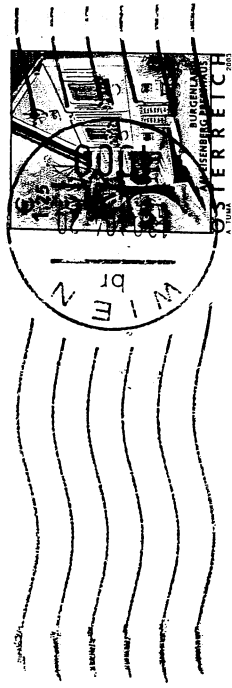
I am writing to support the proposal of the Pink Triangle Coalition for a small allocation of possible unclaimed residual funds from the Holocaust Victim Assets Litigation.

From my perspective, the proposal of the Pink Triangle Coalition should be supported. Gay victims and survivors of the Nazi regime are not easily identifiable through usual channels. They are not likely to participate in other networks or organizations of survivors because of their being gay or lesbian. The final distribution of these funds should benefit all of the class members, not only some of them. Anything less than that would continue such discrimination.

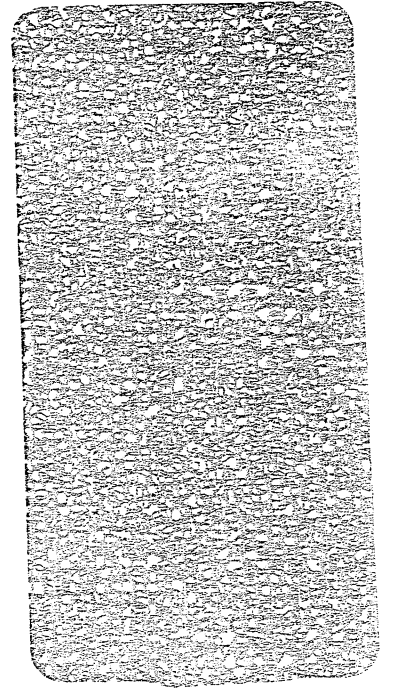
Therefore I support the proposal submitted by the Pink Triangle Coalition, the only organization that represents the homosexual class members in this important case.

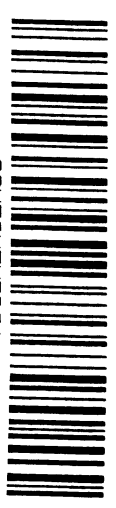

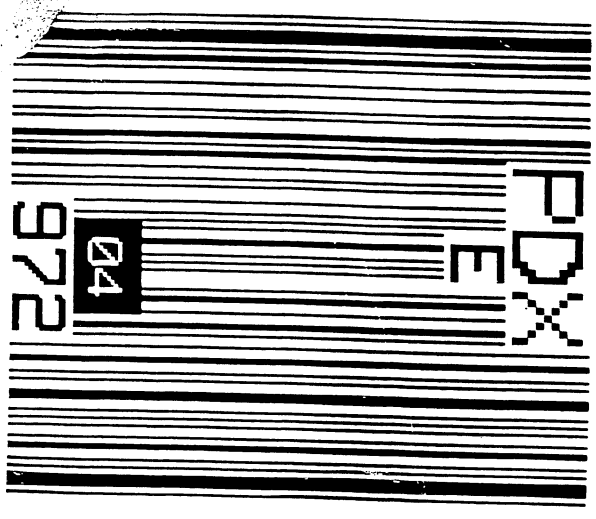
